THE EXHIBIT HAS BEEN DISPLAYED AT PUBLIC LIBRARIES, CHURCHES, YMCA'S AND WAS ON DISPLAY AT AHHAH'S 2ND ANNUAL RESTORATIVE JUSTICE OPEN HOUSE AT UPTOWN KNAUER PERFORMING ARTS CENTER. THE WRITING AND ART FROM JUSTICE RESTORED 3.0 GENERATES DIALOGUE IN THE COMMUNITY AROUND MASS INCARCERATION OF CHILDREN IN THE U.S. AND A MEANS TO ADVOCATE FOR POLICY CHANGE TO END THE CRADLE TO PRISON PIPELINE OF CHILDREN IN POVERTY AND OF COLOR.
